- **ITEMS TO BE SOLD MUST BE HAND CRAFTED BY VENDOR**
- **SELLERS PERMIT OR TEMPORARY SELLERS PERMIT REQUIRED**

Spaces are approximately 10' x 10'

Space rental fee: \$30.00 retail, \$20.00 non-profit organizations for fund raising

Deadline to reserve space is June 15, 2009 (Reserve Space Early)

NO REFUND if cancelled after June 15, 2009

Electrical outlets are limited. If you need electric power, please note this on your application in the space provided.

No gas or diesel generators are allowed.

Set up time: July 4th, 6:30 AM to 9:00 AM. (If you are not set up by 9:00 AM, your space may not be held)

Fair Hours: 10:00 AM to 4:00 PM, July 4th only

Restrooms: Porta-Potties on Art Center grounds

Exhibitors are expected to clean up the area around their booth and remove their trash at the end of the day

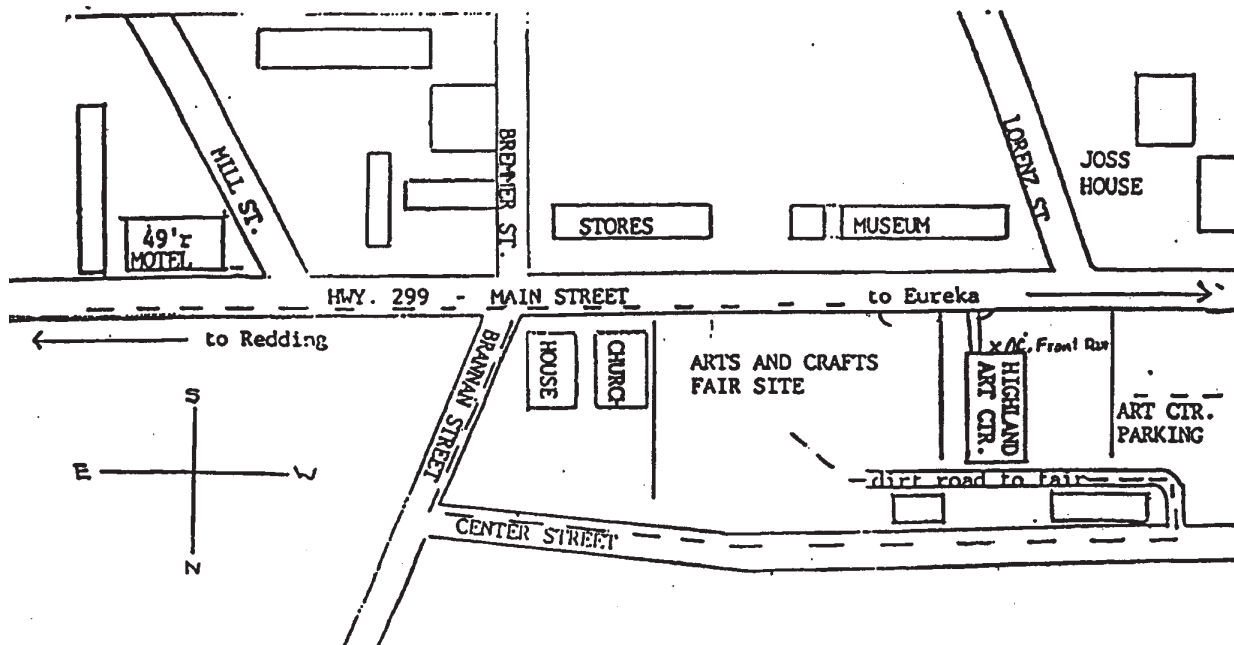
FROM REDDING:

Turn right off Hwy 299/Main Street at Brannan Street. Turn left off Brannan at Center Street, go up the hill...at the bottom of the hill turn left at the grey barn, make "U" turn around barn on dirt road in back of Art Center.

FROM COAST:

Turn left off Hwy 299/Main Street at Brannan Street and follow the above directions from this point.

Pull into fair grounds, UNLOAD VEHICLE AND PARK OUTSIDE OF FAIR GROUNDS **BEFORE** SETTING UP SO OTHERS CAN GET IN TO UNLOAD.
