

HIGHLAND ART CENTER'S 26TH ANNUAL JURIED ART SHOW 2010

- SHOW DATES:** Exhibition will run from October 2 through October 24, 2010.
- DEADLINE:** Entries must be received on or before Monday, September 27, by 4:00 pm. No exceptions. You may bring entries in anytime after Monday, September 6, up to Monday, September 27, 4:00 pm.
- RECEPTION:** A reception for the artists will be held on Saturday, October 2, from 5:00 to 8:00 pm.
- ELIGIBILITY:** Open to residents, 18 years and older, of all Northern California counties.
- ENTRY FEES:** \$5.00 per entry, non-refundable. Membership in Highland Art Center required. (\$20/year/individual)
- LIMIT:** No more than three (3) entries per category will be accepted.
- JURYING:** Jurying will take place at 1:00 pm, Tuesday, September 28. The gallery is closed between 1:00 pm and 3:00 pm during jurying. The juror is artist and instructor, Stock Schlueter, from Eureka, CA.
- CRITIQUE:** A critique by the juror will take place at 3:00 pm, immediately following the jurying. Artists are invited to attend and ask questions.
- CATEGORIES:** PAINTING: Oil and acrylic on canvas
PAINTING: Water-media (transparent watercolor, gouache, casein and acrylic on paper).
MIXED MEDIA & PRINTMAKING: Hand printed work and two dimensional mixed media work.
PASTELS, DRAWINGS: Oil & dry pastel, pen & ink, charcoal & graphite.
SCULPTURE: Three dimensional work in clay, wood, stone, paper-maché, metal, etc. Does not include primarily functional work such as jewelry, pottery, furniture, baskets, turned items, etc.
- NOTE:** Each category must consist of at least eight (8) entries or the work will be grouped with another category at the discretion of the juror. No division will be made within the categories as to representational or non-representational work. The juror reserves the right to move work, which in his opinion, is not entered in the appropriate category.

- Awards are made at the discretion of the juror who may choose to make none, 1, 2, or 3 awards per category. The juror may also choose to make non-cash awards (Honorable Mention).
- SALES:** Highland Art Center retains a 30% commission on sales. Work not for sale must be marked NFS on the entry form.
- CONDITIONS FOR ENTRY:**
1. Original art work only. No kits or commercially designed pieces will be accepted.
 2. No copies of other artist's work, including copies of other artist's photographs.
 3. No teacher assisted class work.
 4. Work must be of the past two (2) years and not previously exhibited at Highland Art Center.
 5. **Two dimensional work must be framed and ready to hang with wire.** Wire must be attached with screws, not clips. No "sawtooth" hangers accepted. No uni-frames accepted. Metal frames must be held together with screws, not clips. Artwork incorrectly framed will not be accepted.
 6. Awards are made at the juror's discretion.
 7. All accepted work must remain for the entire show. Show ends October 24. Entries must be pickup October 25 before 3:30 pm.
 8. Work not accepted may be picked up after Wednesday, September 29.
 9. All reasonable care will be taken with work submitted, however, Highland Art Center accepts no responsibility for loss, damage, or theft of work entered, whether accepted or not.
- PLEASE NOTE:** The final selection of work to be juried for the show rests solely with the juror. Some of the work accepted for jurying may not be hung if space is lacking.
